

**FACTS****WHAT DOES GLOBAL LENDING SERVICES LLC DO WITH YOUR PERSONAL INFORMATION?**

<b>Why?</b>	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
<b>What?</b>	The types of personal information we collect and share depend on the product or service you have with us. This information can include: --- Social Security Number                      --- Account Balances --- Account Transactions                              --- Income --- Credit History    --- Payment History
<b>How?</b>	All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reason Global Lending Services LLC chooses to share; and whether you can limit this sharing.

Who is providing this notice?	Global Lending Services LLC
What we do	
How does Global Lending Services LLC protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.
How does Global Lending Services LLC collect my personal information?	We collect your personal information, for example, when you: --- Apply for financing --- Give us your contact information or give us your income information --- Provide account information or provide employment information We also collect your personal information from others, such as credit bureaus, or other companies.
Why can't I limit all sharing?	Federal law gives you the right to limit only --- sharing for affiliates' everyday business purposes - information about your creditworthiness --- affiliates from using your information to market to you --- sharing for nonaffiliates to market to you State laws and individual companies may give you additional rights to limit sharing. See below for more on your rights under state law.
What happens when I limit sharing for an account I hold jointly with someone else?	Your choices will apply to everyone on your account.

Definitions	
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies. --- Global Lending Services LLC currently has no affiliates.
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies. --- Global Lending Services LLC does not share with nonaffiliates so that they can market to you.
Joint Marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. --- Our joint marketing partners include financial service providers, motor vehicle dealers, and insurance companies.

Other important information
<p><b>Residents of California:</b> Other than for our everyday business purposes, we will not share your personal information with nonaffiliates or affiliates without first giving you additional privacy choices.</p> <p><b>Residents of Vermont:</b> Other than for our everyday business purposes, we will not share the following without first giving you additional privacy choices: (i) personal information with nonaffiliates; and (ii) personal information about your creditworthiness with affiliates or joint marketing partners.</p> <p><b>Residents of Nevada:</b> We are providing you this notice pursuant to Nevada law. At any time, you may request to be placed on Global Lending Services LLC internal do not call list if you do not wish to receive telemarketing calls from us. If your telephone number is included on our internal do not call list, we may still contact you for servicing purposes.
